

**MINUTES OF REGULAR MEETING OF THE  
RINCON VALLEY FIRE DISTRICT GOVERNING BOARD MEETING  
HELD November 20, 2018**

A public meeting of the Rincon Valley Fire District Governing Board was convened on **November 20, 2018 at 6:00 P.M.** at RVFD Station 2; 14550 E. Sands Ranch Rd. Vail, AZ 85641. Present at the meeting were the following members of the Rincon Valley Fire District Governing Board: Chairperson Raymond Phillips, Clerk Michelle Harrington, Member Terry Newman, Member Mark Tate, and Member Kirsten Schlenker.

- B. **October's Financial Reports** – Review, discussion and possible action, of the district's financial status including monthly summary reports.
  - Monthly Financial Report – Motion by Member Schlenker, second by Chairperson Phillips to approve the Financial Report for the month of October 2018. Motion passed unanimously 5 to 0.
  - Expense Report – Motion by Member Schlenker, second by Chairperson Phillips to approve the Expense Report for the month of October 2018. Motion passed unanimously 5 to 0.
  - Monthly Bank Reconciliations and Balance Sheet – Motion by Member Schlenker, second by Chairperson Phillips to approve the Bank Reconciliations and Balance Sheet for the month of October 2018. Motion passed unanimously 5 to 0.

## 7. Unfinished Business

- A. **2019-036 – Review, discussion and possible action regarding the November 2018 Election.**
  - As discussed last meeting, we have discovered that some District residents' ballots do not include an option to vote in the 2018 fire district election. The issue arose from a change in annexation laws sometime in the 1990's in which the voter registration department was no longer notified. However, the elections official and the recorder's office (who oversees voter registration) appears to have been notified. Chief Kahle made numerous attempts to contact the affected Pima County department but only received the one letter, which was previously distributed to board members. Chief Kahle made contact with the executive director of the Arizona Fire District Association and he feels that this is a Pima County problem only. I also spoke with some area fire districts and they have experienced similar problems. Chief Kahle and Laura Bucklin met

with Supervisor Christy's office in an attempt to solve the problem. Christy's office is attempting to get the six related Pima County departments together to develop a workable solution. In the interim, staff is researching files to verify that all voters will have a chance to vote for the next election and we are sending information to everyone. Discussion only. No action taken.

**8. New Business - Note: The Board took agenda items out of order.**

**(Item #8-B – 2019-014)** - Review, discussion and possible action to approve the Canvass of Elections.

- Motion by Chairperson Phillips, second by Member Tate to adopt Resolution #19-011 Authorizing the Official Canvass of Elections for the November 6, 2018 General Election of the Rincon Valley Fire District and approval of the Letter to the Pima County Board of Supervisors showing the results of the election. Motion passed unanimously 5 to 0.

**A. 2019-013** – Review and discussion to recognize the service of Rincon Valley Fire District Board Members during the 2014-2018 term.

- RVFD has three board members that have completed at least their full term in service to the Rincon Valley Fire District. They are:

Michelle Harrington, 2014-2018 +  
Kirsten Schlenker, 2006-2018

Some notable accomplishments include: 11 person minimum staffing, addition of battalion chiefs, full payment of two ambulances, one brush engine, and one fire engine. These resources have been critical in allowing us to provide service to our community.


