- **B.** Fire Chief's Report Reviewed by the Board. Report on file.
 - Chief Tucker has met individually with employees to get feedback.
 - RVFD attended several community events in November, including a pet parade in Academy Village.
 - One firefighter is still off-duty on a work-related injury; his subsequent follow-up with his surgeon is in mid-January.
 - We have outsourced several apparatus repairs over the last few months that we had not anticipated.
 - One of our ambulances was involved in a collision. Everyone involved is okay. Chief Tucker spoke with the ambulance manufacturer, and they agreed that a local shop could repair the damage. Our general insurance company will cover the repairs and attempt to be reimbursed by the other vehicle owner/driver involved.

Our new firefighters are Kamren Overstreet assigned to A-Shift, Station 291 and Jacob Rosson assigned to C-Shift, Station 291.
- Chief Tucker swore in FF Jacob Rosson, and family friends were present to celebrate the occasion.
