## **NOTICE OF NONDISCRIMINATION**

Rincon Valley Fire District complies with Federal civil rights laws and is committed to providing its programs and services without discrimination in accordance with:

- Title VI of the Civil Rights Act of 1964, which prohibits discrimination based on race, color, or national origin (including language).
- Section 504 of the Rehabilitation Act of 1973, which prohibits discrimination based on disability.
- Title IX of the Educations Amendments Act of 1972, which prohibits discrimination based on **sex** in education programs or activities.
- Age Discrimination Act of 1975, which prohibits discrimination based on age.
- U.S. Department of Homeland Security regulation 6 C.F.R. Part 19, which prohibits discrimination based on **religion** in social service programs.

## To File a Complaint

If you believe that Rincon Valley Fire District has failed to provide these services or discriminated you in another way based on race, color, religion, sex, national origin (including language), disability, sexual orientation, or age, you can file a complaint in person or by mail, fax or email no later than 180 days after the date of the alleged discrimination with:

### **Prohibition Against Retaliation**

It is impermissible for Rincon Valley Fire District to intimidate, threaten, coerce, or discriminate against any individual for the purpose of interfering with any right or privilege secured by Title VI, or because the individual has made a complaint, testified, assisted, or participated in any manner in an investigation, proceeding, or hearing under the DHS regulation implementing Title VI (6 C.F.R. §21.11(e)). Any individual alleging such harassment or intimidation may file a separate complaint with DHS.
